

## Avendus Absolute Return Fund becomes the first Indian fund to win at the HFM AsiaHedge Awards 2019

Avendus Absolute Return Fund, a Category III - Alternative Investment Fund and the largest hedge fund in India, has been awarded as the Best Single Country Fund at the 18th HFM AsiaHedge Awards in Hong Kong.

The annual HFM AsiaHedge Awards highlight excellence in Asia-Pacific's hedge fund industry, celebrating the achievements of the best performing funds of the previous year. This edition of the Best Single Country Fund award evaluated the top hedge funds from various APAC countries and weighed them basis their risk-adjusted performance in a combination of Sharpe ratio and absolute returns.

On receiving the award, Andrew Holland, CEO, and Vaibhav Sanghavi, Co-CEO, Avendus Capital Public Markets Alternate Strategies LLP, said, "We are delighted to receive this award. It is a recognition of the team's consistent and outstanding performance over many years. What is special for us is that we competed with six other hedge funds from across Asia (including Australia) and came out with flying colours. Our focus on the process and a disciplined approach towards investments, have helped us deliver consistent risk-adjusted returns."

The HFM AsiaHedge Award becomes another feather in the hat after the Avendus Absolute Return Fund represented Indian hedge funds on a global platform at The EurekaHedge Asian Hedge Fund Awards and was adjudged the Best India Hedge Fund of 2019. These awards, held in May 2019, celebrated the best performing Asian hedge funds of 2018 in categories across the board in regional and strategic mandates that not only reflect the industry's performance but also highlight outstanding performers of the year.

India witnessed the entry of this asset class (Alternative Investment Fund - Category III) when the Securities and Exchange Board of India allowed the launch of hedge funds in the year 2012.
